



# Coloma Craft and Flea Market 2025

## VENDOR INFORMATION AND REGISTRATION FORM

The Coloma Area Historical Society (CAHS) is sponsoring a series of Flea & Craft and Markets. See dates below. Vendors are invited to sell crafts, antiques and collectibles, rummage, seasonal produce, baked goods and flea market items in an outdoor market in the Coloma Community Park, 232 S Front Street (aka CTY CH). Some sites are shaded, parking is ample, restroom facilities handy, and there is a fun playground for the kids on the grounds.

The Coloma Craft & Flea Market will be held **rain or shine**, from **9 am to 2 pm. No refunds/transfers.** Bring your own canopy, tables and chairs. Setup may begin at 8 am in your pre-assigned, pre-marked, 10x12 area immediately adjacent to the historic Spalding General Store Museum and Carriage House. Vendors are asked to clean up and take home personal belongings after the sale. *No early take downs.*

**Each space reserved and paid for 30 days, or more, before market day is \$10.00. Each space reserved and paid for less than 30 days before market day is \$15.00. Vendors pay \$20 for an available site on market day.** PLEASE NOTE: **Any preregistered vendor who has not checked in at the Registration Table by 9 am, OR notified Julie at cell #(414) 522-6751, will give up their advance site and it will be reassigned.** CAHS does not have canopies for rent. Flea market spaces are 10x12.
